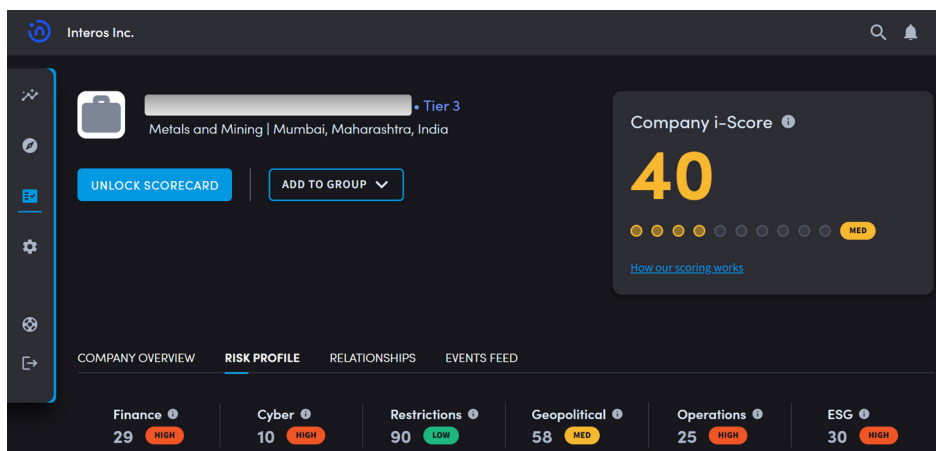


Figure 1. Quickly assess a potential supplier across multiple risk factors with Interos' i-Score™

Instead of relying on multiple, single-threaded risk intelligence solutions for complete coverage, the Interos i-Score™ provides a unique measurement of risk across six key risk factors, each with multiple sub-factors and dozens of attributes to better assess a supplier's risk posture.



Financial: Assesses risk based on sixteen financial attributes using data collected from three of the top four global sources for public and private companies



Restrictions: Based on twenty three (and growing) global sanctions lists for trade and financial restrictions, national security, and human rights violations



ESG: Includes more than forty attributes assessed at both the entity and location level to provide a balanced approach to environmental, social and governance risk



Operational: Based on the location of the entity and its susceptibility to climate and weather-related events, natural and man-made disasters, with an emphasis on the ability to recover quickly



Geopolitical: Covers two dozen attributes that assess international disputes and potential conflict, political stability, terrorist activity, political and civil rights, unemployment and education levels



Cyber: Assesses cyber security and hygiene practices, as well as governmental Internet/Telecom interference, regulations and data protection policies

This risk data is continuously monitored and updated, ensuring that procurement teams are working with the most current and accurate risk intelligence when making sourcing decisions.
